### Overview

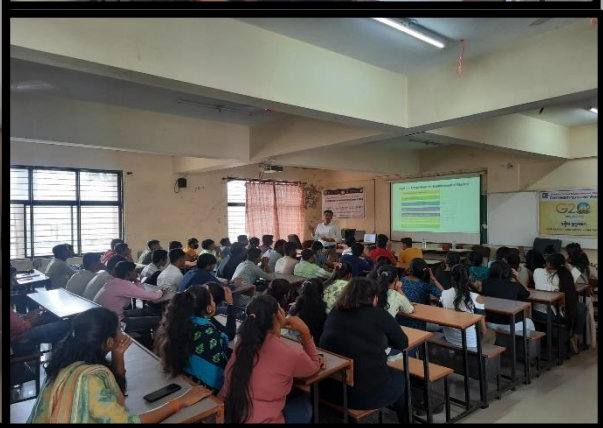
