Report:

Placement cell and SSIP cell of Government Commerce and Science College Dahej has organized an industrial visit on 10th January 2024 to BEIL Infrastructure Ltd. located in GIDC estate, Dahej for the T.Y.B.Sc. Students. Total numbers of students were 26 accompanied by Principal Dr. Leena Dave and four professors; Dr. jaimin Shah, Ms. Gayatri Govalvanshi, Dr. Gourav Upadhyay, Mr. Abhishek Vishvakarma. Company provided the bus facility for the students and we all reached the site at 12:15 pm. After the security check and gate pass

formalities students were taken to the conference room. Mr. Mahesh Trivedi (General Manager, BEIL, Dahej) welcomed the principal and faculty members and briefed about the industry, then a short interactive session was conducted by Mr. Sagar Soni (Assistant manager-HR & Admin) and his team. He encouraged our students to join the company and explained the eligibility criteria for joining the company. He also explained the companies policy to promote higher education for students who have weak economic background. A short film was screened showing vision, mission, work profile and activities performed by the company. The company's efforts towards the safety and environment awareness were also discussed followed by tea and breakfast. Students and faculties were divided in to two batches of 13-14 students. We were escorted to various departments and areas by the assigned coordinators; Ms. Kruti Thumar, Mr, Dhyaneshwar Patil and Mr. Varad Bhatt. Initially they briefed us about the safety and guidelines to be followed by everyone inside the industry. Then they took us to various departments starting from the material storage, sampling of waste that they received from various industries, the drying unit, manual dyeing unit and mixing unit, the cell for land filling of the dried waste material, MEE plant (multi effective evaporator), Incinerator unit and ETP (Effluent treatment plant). The coordinators guided us about each of these units in brief, showing their importance, safety measures while performing these unit operations. During this visit students enthusiastically asked various questions and raised their doubts, which were patiently addressed and satisfied by the concerned coordinators. After the completion of site visit; lunch was arranged and then we were dropped at college in their bus. Overall the industrial visit to BEIL Infrastructure Limited enriched our knowledge and experience; also provided a great opportunity to learn practically through demonstration, interaction which will help the students in their carrier growth.
