Introduction

Parul Innovation and Entrepreneurship Research Centre (PIERC) organized an insightful session on **Angel Investment and Venture Capital (VC) Funding Opportunities for Early-Stage Entrepreneurs**. The session was conducted by **CA Heet Sedani**, who shared his expertise on startup financing, investor expectations, and strategies to secure early-stage funding. The program was designed to guide budding entrepreneurs of Parul University in understanding the process of raising funds, preparing for investors, and scaling their ventures effectively.

Objectives of the Session

- To provide participants with a **broad understanding of Angel Investment and VC funding opportunities** available in India and globally.
- To guide students and early-stage entrepreneurs through the step-by-step process of raising funds.
- To emphasize the importance of pitch decks, business validation, valuation, and legal compliance for investment readiness.
- To inspire participants to build scalable ventures by exploring **funding networks**, **incubation centres**, and **government support schemes**.







Learning Outcomes

By the end of the session, participants were able to:

- Differentiate between **Angel Investors and Venture Capitalists**, and identify when to approach each.
- Understand the **funding lifecycle of startups**, from bootstrapping to IPO.
- Learn the essential steps for **investment readiness**, including preparing a pitch deck, understanding valuation, and showcasing traction.
- Gain awareness about the **due diligence and negotiation process** involved in funding deals.
- Explore **platforms**, **networks**, **and government initiatives** that support early-stage entrepreneurs.

Session Details

The session, led by **CA Heet Sedani**, offered a practical roadmap for entrepreneurs aspiring to raise early-stage funding. He began by explaining the **funding ecosystem**, highlighting the roles played by Angel Investors and Venture Capitalists in supporting startups beyond financial capital—through mentorship, strategic guidance, and industry connections.

He elaborated on the **funding journey of startups**, starting from bootstrapping and friends & family support, moving on to seed investment through Angel Investors, followed by VC rounds, and eventually private equity or IPO. This gave attendees clarity on the growth path and financial milestones of startups.

Key highlights from his talk included:

- **Pitch Deck Essentials**: Covering problem, solution, target market, business model, traction, financials, and exit strategy.
- Valuation Insights: Simplified overview of pre-money and post-money valuation, methods like comparable multiples, and investor expectations.
- **Due Diligence Process**: Financial, legal, and compliance checks required before investment closure







• **Negotiation and Term Sheets**: Balancing equity dilution with long-term sustainability of the business.

CA Sedani also warned about **common mistakes entrepreneurs make**, such as presenting unrealistic valuations, lack of market research, poor financial planning, and underestimating compliance requirements. He stressed that investors invest in **teams and execution capabilities**, not just ideas.

The session also highlighted **government initiatives** such as the Startup India Seed Fund, Atal Innovation Mission (AIM), and various State Startup Grants that help bridge funding gaps.

An interactive **Q&A session** allowed participants to raise queries on practical aspects such as:

- How to identify the right investor network?
- What is the ideal stage to seek angel funding?
- How to present traction and market validation?
- How to balance ownership dilution in early rounds?

The discussion concluded with an inspiring note: "Investment follows innovation and execution, not just ideas."
